Dear St. Louis County Residents,

I am certain that every St. Louis County resident recognizes that it has been a very difficult few years for the average American citizen. attracts investment in the region; as evidenced by the recent opening of the NARA (National Archives and Records Administration) Facility in Spanish Lake and the newly planned expansion of the River City Casino in Lemay.

I also believe that the future of our Country in general and our region specifically, are in the highly skilled service and manufacturing fields; these will include areas like biosciences, pharmaceutical, health care and information technology. St. Louis County has been active in attracting companies like Gallus Biopharmaceuticals (Berkeley, MO) to the region, as well as retaining existing enterprises like Leinco Technologies (Fenton, MO) by fostering additional expansion opportunities. However, it will be our responsibility as a community, to be trained to fill these well-paid and highly-skilled positions. Education and vocational training of our workforce will become critical to the long term success of the St. Louis region.

Moreover, I think we also have to look beyond our own local or even national boundaries for regional growth. St. Louis County must prepare itself to compete in a global economy. Our recent designation as a Free Trade Zone moves us in that direction.

As a community, we have to decide where we want to be in 5, 10 or even 20 years from now; our short term, medium term and long term priorities must be reflected in those 5, 10 or 20 year plans. Sometimes things may be difficult because some sacrifice will be required; however we must do what's necessary to make sure our St. Louis community is a competitive, 21<sup>st</sup> Century region.

## Recycling Becomes Me

Did you know that by recycling just 5 percent more than last year, St. Louis County could fill the Edward Jones Dome three feet high, 25 times over with the amount of recyclables collected? Increasing curbside recycling is the goal of the St. Louis County Department of Health's new public education initiative called "Recycling Becomes Me." Featuring preposterous visuals that interject common recycling containers into unexpected situations, the campaign makes the point that everyone can recycle and that it can be a part of many different lifestyles.

The campaign is being promoted at local events throughout the next year. Contests and prizes are part of the fun! The campaign was created at no cost to the county through a partnership with Curbside Value Partnership (CVP). CVP is a national, invitation-only program designed to increase participation in curbside recycling programs through education and measurement. CVP receives funding from corporations in the container industry who need an immediate supply of recycled materials to make products. St. Louis County is honored to be one of only two communities selected as a 2011 CVP partner.





## Volunteers Needed at New Animal Shelter

The new St. Louis County Animal Care and Control Adoption Center, which opened November 7, is providing expanded services to the region and improved care for dogs and cats that come to the state-of-the-art facility.

“We are expanding our volunteer program, along with other services,” said Rebecca Smail, program manager for Vector Control and Veterinary Services.

Smail said her staff in both animal control and vector control got a morale boost after moving from two inadequate buildings into the new facility at 10521 Baur Boulevard in Olivette.

“This new center will double the space for cats and dogs and will highlight our program for offering spayed and neutered pets for adoption,” Smail said.

The center includes:

- Separate areas for dog and cat adoptions
- Meet-and-greet rooms for potential adopters to interact with pets
- A state-of-the-art veterinary suite for spay and neuter surgeries
- Separate areas for quarantined and aggressive animals
- An outdoor play and training area

The new shelter will also help the county expand its partnerships with the Humane Society of Missouri and the Animal Protective Association.

The center is accepting applications for the first phase of a new volunteer program that will allow the public and county employees to assist in the care and adoption of animals.

The center is launching the HALO Team (Helping Animals Lives and Outreach), which will provide exercise, enrichment and mental stimulation for the dogs and cats in the facility's adoption area.

## Local Students Participate In Lemay Area Cleanups

As part of the service learning initiative adopted by Hancock High School, over 60 seniors teamed up with St. Louis County on October 28 to help improve properties in Lemay. Under the leadership of high school faculty members Keith Touzinsky, Anna Eyre and Nikki Herman, students in the senior class removed trash, debris and brush from over 13 properties and 2 alley ways. They collected and transported enough brush to fill a 20 yard and 40 yard dumpster, enough trash to fill a 40 yard dumpster and over 4,000 pounds of scrap metal.

Hancock High School seniors are now required to perform service hours in order to walk across the stage at Graduation, but they didn't feel as if it were a requirement to be there. “It felt good to get out and do something for the community,” admitted Eldin Dedakovic. “Seeing the conditions that some of these houses were left in makes me very grateful for what I have,” commented senior Miranda Rogers. “This was an eye opening experience.”

## Free Income Tax Assistance to Senior Citizens

Free assistance with simple federal and state income tax forms and the Missouri Property Tax Credit Claim (Mo-PTC or "Circuit Breaker") is available through the St. Louis County Department of Human Services' County Older Resident Programs (CORP).

Tax assistance is provided by appointment to St. Louis County residents who are 60 years or older, with income of \$50,000 or less. South County locations include: South County Government Center (Mehlville), St. Louis Deaf Community Center (Brentwood) and Oak Bend Library (Oakland). North County locations include: North County Government Center (Hazelwood), Dellwood City Hall and St. John Municipal Center. Appointments may be scheduled, beginning January 30, 2012, Monday-Thursday, 9 am – 2 p.m. For South County locations, please call 314-615-4037. For North County locations, please call 314-615-7447. ## North County



### NARA Facility Opens in Spanish Lake

Where else can you see Elvis Presley's fingerprints? How about Humphrey Bogart's application for enrollment or fascinating correspondence between former United States presidents? None other than the National Archives and Records Administration Facility (NARA) in Spanish Lake.

The new facility is one of the largest repositories of personnel-related records for both military and civil service employees. As a tourist destination, it features museum-quality exhibits; viewing rooms for archivists, researchers and genealogists; and a hub for historical education via Internet broadcasts. With its treasure trove of historic documents, the nation's record-keeper and its more than 100 million documents are expected to draw over 10,000 visitors annually.

The construction of the facility in Spanish Lake pumped \$435 million into the local economy and involved more than 300 construction jobs. NARA's local workforce of nearly 800 employees represents the largest group of its personnel outside of the greater Washington, D.C. area.

## A Game Plan for Growing Our Economy

There's no doubt that the closure of the two Chrysler assembly plants in Fenton carved a huge hole in the regional economy. It's a loss still rippling through the St. Louis area today.

AECOM, a nationally-recognized consultant, spent the past 18 months conducting interviews and collecting data on the auto plant closure to better assess its economic impact and determine a strategic plan for recovery. The study culminated with the creation of a comprehensive Regional Economic Adjustment Strategic Plan and the following recommendations:

- Build upon capacity for advanced manufacturing, plant and life sciences, and clean technology
- Streamline and improve resources to assist entrepreneurs and small businesses
- Enable local companies to better penetrate global markets
- Address critical infrastructure needs to sustain long-term economic growth
- Organize and align workforce training with business retention and expansion efforts
- Improve regional economic development collaboration and leadership
- Enhance collaboration between St. Louis City and St. Louis County

"With this study we seek to better understand the scope of the impact and our regional economic strengths," said St. Louis County Executive Charlie A. Dooley. "And in so doing, develop a game plan for growing our economy."

The State of Missouri, St. Louis County Economic Council and City of Fenton commissioned the AECOM study with funding provided by a United States Economic Development Agency grant.

### Registry To Help County Residents Prepare for Emergencies

The Department of Human Services is pleased to announce it is developing an Access and Functional Needs Registry for St. Louis County residents. Expected to launch in the next few months, the registry will allow individuals with access or functional needs, including the elderly, individuals with disabilities or temporary mobility issues, to provide emergency response agencies with information about their needs. This information will assist emergency response agencies to better plan to assist individuals that, due to a medical condition or physical impairment, may have difficulty responding to a disaster or other emergency safely and in a timely manner.

Registries are quickly becoming indispensable tools for emergency planning. The City of St. Louis, as well as a handful of other counties in Missouri already offer this service to their residents. Participating in the registry will be free and strictly voluntary. Eligible residents will be able to register online, via mail or with assistance from an approved volunteer. ### *Bonfires*

Bonfires are exempt from St. Louis County and State of Missouri Open Burning rules. Prior to any type of recreational burn, residents must contact their local fire protection district. Only clean, untreated wood may be burned, and the burn is limited to 16 square feet. Bonfires must be monitored at all times and a means of extinguishing the fire must be readily available. The smoke, soot or cinders of bonfires must not become a nuisance to any neighbor.

### *Snow removal*

When it snows, St. Louis County first plows and salts roads that are part of the St. Louis County arterial and collector road system, due to their importance in connecting people to emergency services and businesses. After these streets are cleared, snowplows begin to clear and de-ice subdivision roads. St. Louis County-maintained routes should be addressed no later than 24 hours after the conclusion of a storm.

During snowstorms, the Department of Highways & Traffic asks for residents' assistance in parking cars off streets to allow plows easier access when clearing and to wait 24 hours before calling to inquire about the status of snow removal.
